Our speaker will be Ashley Moulton

Why would a young woman spend time fertilizing native grass on an undeveloped barrier island? Come find out at the November 3rd meeting of the Virginia Native Plant Society Pocahontas Chapter. The young woman, Ashley Moulton, will present the results of her Master's thesis, "Short-term Effects of Nutrients on a Barrier Island Grassland Community," including the important implications of how the functional diversity of plant communities can be altered by global and local disturbances in coastal systems.

A curious plant ecologist with loads of enthusiasm for all things green, Moulton is a graduate student at Virginia Commonwealth University's Coastal Plant Ecology Laboratory. She did her research on one of the 14 undeveloped barrier islands off the Delmarva Peninsula that make up the Virginia Coastal Reserve created by The Nature Conservancy. Her research interests include understanding how feedbacks between abiotic (non-living) and biotic (living) factors influence the distribution of vegetation in coastal landscapes, but it was her current job experiences in urban nutrient management as an Agricultural and Natural Resources Technician/Master Gardener Coordinator for the Virginia Extension Cooperative Office in Chesterfield that led her to question how plant communities that historically have limited plant growth in coastal barrier island systems respond to nutrients.

Minutes of the Pocahontas Chapter, VNPS Meeting October 6, 2016

Welcome: Leslie Allanson called the meeting to order with about 35 persons present.

Program: Catharine Tucker introduced the program presenter, Dr. Joan Maloof, Founder and Executive Director of the Old Growth Forest Network and Professor Emeritus at Salisbury University. Dr. Maloof's program title was "Old Growth: Learning from the Forest."

Dr. Maloof began by stressing the importance of trees in cleaning the earth's air and water as well as providing habitat for animals. In the 1700s, Virginia was 80-90% forested. The 1800s saw that decrease to 40-60% forested. By 1930, the forest cover was at its lowest point. Although there was improvement between 1930 and 1980, the current trend is for a further decline in forest cover. The speaker's first book, Teaching the Trees: Lessons from the Forest, explores the ecological relationship between trees and other organisms. An assortment of trees in the forest encourages biodiversity. 80% of terrestrial species on the planet is found in forests. If only one tree species is used to replace an old growth forest, 95% of biodiversity is lost. Dr. Maloof's second book, Among the Ancients: Adventures in

the Eastern Old-Growth Forests, deals with old-growth forests in twenty states in the Eastern portion of our country, an area which has only 1% of these forests. The aim is to encourage advocacy in the future by providing opportunities to experience nearby old-growth forests. The author founded the Old-Growth Forest Network to preserve, protect, and promote the few remaining stands of old-growth forest in the United States. Presently, 58 forests in fifteen states are in the network. Four more are on the way. In addition, a Private Forests Network also exists. Dr. Maloof presented our own Vice President, Catharine Tucker, certification as part of the Private Forests Network for her 70 acres protected with an easement. Dr. Maloof's upcoming book, Nature's Temples: The Complex World of Old-Growth Forests, examines the science behind whether or not management is required for old-growth forests. She makes a strong case that eliminating management is a better choice since it leads to higher carbon sequestration, more plant and animal diversity, and more beauty. Next year, Dr. Maloof and famed photographer, Robert Llewellyn, will publish Seeing Forests. To learn more about Dr. Maloof's subject, visit www.oldgrowthforest.net.

Catharine announced the following speakers: November, Ashley Moulton; January, Johnny Townsend; February, John Hayden.










**Minutes of the Pocahontas Chapter, VNPS Meeting
September 8, 2016**

Guided Walk: Prior to the meeting, Grace Chapman, Director of Horticulture at Ginter Botanical Garden, led a guided walk of the new native plant garden at Ginter.

Welcome: Leslie Allanson called the meeting to order with about 50 persons present.

Program: Catharine Tucker introduced the program presenter, Robert Whitescarver, soil scientist and conservationist. His topic was “Native Communities in a Sea of Invasives: The Stories.” Using examples from his farm in the karst topography of Augusta County, Virginia, Bobby emphasized the care needed for land and streams. Widely-planted Kentucky 31 tall fescue is toxic to cattle and birds and has a negative impact on trees. Native plants are a major key to bringing back in abundance brook trout and the northern bobwhite. In order to clean up our streams and rivers, fencing cattle out of the water is essential. A riparian forest buffer can greatly increase the in-stream processing of nutrients and organic matter. A buffer of native trees, appropriate for the soil, provides leaves for the shredder community of macro-invertebrates (mayflies, stoneflies, and caddisflies) in the streams. In turn, the shredder community feeds fish and birds. Aiding in progress towards cleaner streams, the 3rd U. S. Circuit Court upheld the Clean Water Act, which affects the six states surrounding the Chesapeake Bay. The large and appreciative audience participated in a lively Q and A session following the program.

Business Meeting:

There were no corrections or additions to the April 7, 2016 minutes.

Richard Moss, treasurer, reported \$4,901 in the treasury plus \$140 worth of books sold at the meeting.

The chapter has 125 members.
